Blue Ridge Colony

The Colony is planning to place the pivot on the land where they bought irrigation acres for it. They would like to get irrigation next year on another quarter south from it – SW 24-3-28-W4 which was already classified for irrigation. This is for information only.

Standoff Colony - Annual Acre Agreement

The Standoff Colony would like to apply for Annual Acre Agreement for 60 acres on NW 18-6-25-W4. The land was already classified for irrigation in 1926. These assessed acres were transferred to other lands for pivots.

TransAlta Corporation - Riplinger Wind Power Project

Fred informed the Board that in the area of the proposed TransAlta project is 2,323 acres which are already classified for irrigation. Board decided to send letters stating our concerns to Alberta Utilities Commission, to the Premier of Alberta, to the Minister of Agriculture and Irrigation, to Joseph Schow, MLA for Cardston-Siksika, and to TransAlta. The letter is to state that the UID objects strongly the wind turbines being installed on lands that have been classified for irrigation.
