## Folsom Dairy Ltd./United Irrigation District Bridge Agreement

The draft agreement was reviewed. David suggested that the annual inspection of the bridge could state the UID or qualified representative to allow for an engineer as needed. It was also suggested that a point number 4 be added to include Folsom Dairy Ltd. responsibility to clean up any effluent spillage on the bridge usage along with notifying the appropriate regulatory bodies.

#### **Cattle Along Glen Lateral**

Fred spoke with Mr. Barfuss about the issue. He is willing to work on some solutions to reduce problems of potential water contamination.

#### Village of Glenwood Water Spray Park Runoff

Mr. Chad Parsons, CAO of the Village attended the meeting at 10:00 A.M. to request the UID allow open ditch water runoff from the proposed spray park into the UID conveyance works. After discussion the Board indicated that any runoff needed to be in a pipe from the park before entering any UID system.

Alberta Transportation for Abandoned Road Crossing Culverts to be Filled with Cement
There are possibly 3 road crossings that need to be filled at a cost of about \$1,600 per crossing. It is
hoped that a meeting can be arranged between the parties to determine which ones need filling.

Torrie Request to Use UID Easements for Possible Waterline Construction to the Subdivision
Mr. Torrie has requested the opportunity to use the UID easement for the Lateral E pipeline to
install a waterline to his subdivision if he is able to get permission from the Village and the County.
The Board would prefer he attempt to get his own easements but if he is unable to do so the UID
will work with him. Either way, the Board would like him to contact all the landowners advising
what he plans to do. If the UID easements have to be used, the UID would like the contract work of
installing the water line.

## **Future Upgrading of the UID Computers**

There was discussion about how to back up the QGIS mapping program on the UID computers. David suggested David Rolfson be contacted as he works with GIS; Cannon Smith or Mark Porter of EID might be able to help. All UID computers are aging and will need upgrading in the near future. Brandon Gibb MOVED that the 2 ditchrider laptops and the main office computer be upgraded, the present main office computer be moved to the Board room and the present boardroom computer be held in reserve for possible future use as needed. SECONDED by Daniel Hunsperger.

## **IRP Funding**
