Virtual meeting with AEP Dam Safety team and the UID

The zoom meeting was scheduled for 10:00 am with Jenna Montgomery and other members of the team for Dam Safety and our Board of Directors and Fred. The purpose of this meeting was to discuss what the UID needs to do in order to be in compliance with the regulations.

After the initial introduction, Jenna explained the table that she had sent us previously. She explained that AEP has not changed its requirements since 2015 when dam safety inventory was done, however, they added consequence classification. AEP needs to be aware what can happen in case there is a sudden release of water from Cochrane Lake and what kind of risks are there. If there are any possible risks, there needs to be an emergency preparedness plan in place.

The Board members explained why they do not agree with Cochrane Lake being a dam of high consequences and the UID would like AEP to change the ranking of our dam.

The UID might even change the way how we operate the lake. The Board has concerns about the cost for all documents and inspections which can not be done by the UID.

No decisions were made and the AEP will connect with the UID again.

Craig B. Smith will contact Dennis Prince as he might be a qualified engineer for this kind of work.

Tools for the UID

Fred asked the Board for an opinion whether to buy 1" cordless impact which would cost around \$1,400.00 and would be very useful. He also asked whether to buy a leaf blower to clean the snow off the solar panels. After discussion, the Board agreed to buy the cordless impact but not the leaf blower. A simple broom with a long handle is much more efficient to clean the snow because the blower cannot reach the top of the panels anyway.

Salaries 2022

The inflation rate for Alberta in 2021 was 4.3%. The Board discussed salaries for full-time employees but the final decision has not been made.

Ditchrider's position

Fred was asking the Board for an opinion on Ditchrider's position, what kind of position it needs to be, fulltime or only for irrigation season? He would prefer at least a seasonal position and there needs to be at least three months long initial period of probation.

Accounts receivable for rates from 2020 and 2021

All rates for 2020 were paid by the end of December 2020.

The accounts receivable for rates from 2021 are \$\$5,758.02 as of today and ratepayers who owe the UID are: Fox, Francis, and McLeod.

Water rates for 2022

Annually, the Board discusses the water rates for the upcoming year. Based on the financial commitment related to modernization projects, our district will need to increase rates by at least 3% each year until the loan is fully repaid.

The Oldman Watershed Council is kindly asking for ongoing support in a letter from January 4, 2022. Their suggestion is a standardized rate of 3.2cents per irrigated acre.

Waterton Biosphere Reserve Association

As this association requested participation from the mountain districts, Fred made initial contact with them. They suggested a zoom meeting with our district in February. Board is not interested to attend the meeting.

Letter from Al McEwen

Alan delivered us a letter where he is inquiring about the possibility of obtaining additional water rights. He is planning to subdivide the parcel on NE 20-5-27-W4 which is under his farm company name: 412199 Alberta Ltd. He is looking for around 25 acres at the Waterton River bottom. The land is not presently assessed for irrigation. The water source for this parcel would come of their existing pivot.

The Board reviewed the letter and we will respond to Mr. McEwen. First, the land needs to be classified for irrigation, and then he needs to purchase permanent assessed acres to be transferred onto his property. If the classification proves that the land can be irrigated, the Board will permit to supply water via the pivot pipeline. The UID does not have any assessed acres for sale currently.
