The Belly River flow and damage on headworks

The river flow is dropping drastically and it is about three weeks ahead compared to last year's data. We have had to turn down our canal to meet the required minimum river flow. To maintain Lateral A & B we might ask Alberta Agriculture and Irrigation to let more water go down the river. The cooperation with them has always been good.

When Fred and Neil were checking our headwork, they noticed scraped dirt, a barbwire support brace broken and one of the steel posts was bent. The damage has been caused by a front-end loader tractor we believe belongs to Blue Ridge Colony. The UID will repair it and a bill will be sent out to them. A letter explaining the damage and warning to not use our headwork structure for swimming will be sent out as well as swimming is not permitted there. The UID is concerned that someone can get hurt.

Taylor's are irrigating our canal bank

Fred noticed that Taylor's farm was irrigating our canal bank to grow grass. The UID let them keep sheep there to graze weeds. There are no assessed acres and they are pumping water straight from the canal. Fred talked to them and they stopped irrigating the canal bank.

Direct-Ag Services land on NE 36-4-27-W4

We were able to get the information from Cardston County that Direct-Ag Services still has 5 acres zoned as agriculture. However, irrigation-assessed acres were removed from the land when land zoning was changed to recreational. The agricultural crop is not allowed to be irrigated under the agreement for the RV campground.

Ted Shipley's land on SE 36-5-27-W4

Another piece of information from Cardston County is that all of Ted's land on SE 36-5-27-W4 is zoned as commercial/recreational. He has agricultural crop on the south side of the land and he has assessed acres there as well. Ted is in touch with the county to change the zoning for that part of the land.

Barn Dance land on NE 31-4-27-W4

This land is also zoned as commercial/recreational. They have irrigation-assessed acres that are used to refresh the lake.

Jim noticed weeds growing on the island on that lake and Fred will speak to Trevor Kunked to maintain the weeds so they are not spread with the irrigation water as the water from the lake gets back to our system.

Irrigation Council Meeting/Tour at the UID

August 1st is the day for the meeting with the Irrigation Council. The exact time will be decided later. The Board discussed the agenda, places to visit during the tour, and options for lunch. Honorable R.J.Sigurdson, Minister of Agriculture and Irrigation will be invited to the meeting.

BRID inter-district tour on July 6th, 2023

Fred and Viera attended the event. The tour was very interesting and long and we visited many places. Fred also talked to the Minister of Agriculture and Irrigation during the tour.

Stampede reception 2023 hosted by Honourable Devin Dreeshen, Minister of Transportation and Economic Corridors

Fred attended the event on July 9th in Calgary. He had a good discussion with the minister about expansion and new projects in our district. Honourable Danielle Smith, Premier of Alberta was present at the event as well.

Blue Ridge Colony - seepage from a fish pond

Fred talked to the colony and they are willing to cooperate and repair the bank. They are going to drop down the level of the pond in the fall and line the bank with clay. Duane suggested that Fred should supervise the work.

Collin Beazer

Collin Beazer bought the property across from the Barn Dance on the Rex Wynder land and he was asking for a Household Purpose Agreement in the near future. Three Board members were in favor and two abstained. Mr. Beazer will get an agreement and all infrastructure will be at his cost.

Fred's accident

Fred was hauling PVC pipe with his own truck and Larry Lybbert's trailer from Calgary. Rudy Hengerer crossed the highway and ran into the trailer. The trailer was damaged and Mr. Hengerer was charged with two traffic violations.

Fred's insurance does not want to cover the repair of the trailer. The quote for repair is around \$4,800.00 from FalCan Industries where the trailer is currently parked. As of July 10th, his brother Joachim Hengerer said that he would either repair the trailer or pay for repair. Fred suggested buying the trailer from Larry Lybbert for the UID.

Nicholas Barfuss MOVED to buy the FalCan Industries trailer from Larry Lybbert for \$ 9,000.00 and let Joachim Hengerer repair it to our specifications; SECONDED by Duane Nelson.
